CORRIGENDUM

Tripura State Co-operative Bank (TSCB) had issued a Request for Proposal (RFP) for the procurement of 400 biometric fingerprint scanners, intended for deployment across TSCB branches. The purpose was to procure devices compatible with the Core Banking System (CBS), ensuring compliance to multifactor authentication in tandem to RBI and NABARD guidelines.
